## **DSSA ACT of 2010 DEFEATED**

As proposed by Senator John McCain, the Dietary Supplement Safety Act of 2010 was soundly defeated recently as thousands of emails, phone calls and faxes poured into the Senate opposing the bill that would have wiped out current legislative protections for dietary supplements.

So many messages were arriving at the Senate that the entire Congress began to notice. Senator McCain eventually met with Senator Orin Hatch, a champion of natural medicine, and told him that he was withdrawing his support for the bill he authored, the so-called Dietary Supplement Safety Act (S 3002). This means that the bill as written is now dead. Thank you for your support and taking action.
