NATURAL THERAPIES CERTIFICATION BOARD NEWS

Attention All NTCB Members

Due to increased risks and litigation, NTCB will no longer recertify any member who has not completed an approved Coaching Correspondence Course & Basic Skills Workshop. This includes Specialists who were grandfathered to the NTCB from the former NBCB (Neurotherapy & Biofeedback Certification Board). Effective immediately, the NTCB Executive Board has voted that all members have one year from their current renewal to complete this requirement.

IMPORTANT NOTE: Recent members who found themselves in trouble with the FDA and/or State Medical Board were found using a medical Client Intake Form. This is illegal unless you have a clinical license. This means that ALL NTCB members may not use a medical intake form. We cannot stress this enough.

You cannot request client medical history on your informed consent form. This is practicing medicine without a license. Remember the client signs and takes the form with them and you retain a copy for your files.

According to our Counsel, more Practitioners are finding themselves in legal trouble. Certification was put in place to help avoid this very issue. Certification also brings professionalism and integrity to our Natural Therapies community. If you are a practitioner offering services without the protection of certification and insurance, you are a target for future legal issues.

The Harsh Truth

If you want to practice illegally by not being properly licensed or certified you really deserve to pay attorneys thousands of dollars to stay out of jail, get certified or licensed and keep your business. Or you deserve to go to jail, pay your fines and close your business. Either way, you lose.

The truth is you could have avoided this whole mess. All you needed to do was become properly licensed or certified, use a solid code of conduct and informed consent form, coach and empower your clients and forget all about making illegal, false and misleading claims. ✚ Under Attack In Colorado

A select group of non-elected, unaccountable individuals participating in a workgroup hosted by the Colorado Immunization Program (CIP) wants to make it harder for you to exercise your religious and personal rights to exemption from vaccines in the State of Colorado.

This group plans to change the exemption form that Colorado Parents have used, and the Colorado Legislature has supported for years, to exempt their children from one or more of the vaccines required for school. They plan to make three major changes.

First, the new form will require parents get a signature for their personal exemption from a physician, nurse practitioner or a public health official. This in effect changes the personal exemption to a medical one with total disregard to the fact that many Colorado families utilize alternative medicine.

Second, it requires the religious exemption be signed by the "religious leader". Requiring a "religious leader" to approve a personally held religious belief is a violation of religious freedom protected by the US Constitution.

Third, the new exemption form is two pages long and requires parents to not only sign an exemption for vaccines that are required for school, but also for vaccines that are simply recommended like HPV vaccine and flu vaccine. The form also states you will be asked to review this document again at 4, 6 and 12-15 months of age, then again at 4 years old and 11-12 years old. This is medical harassment.

This small group of vaccine "stakeholders", all of whom support the idea that everyone should be vaccinated with every vaccine according to the "one size fits all" government schedule, doesn't even think this is a rule change worthy of the appropriate public hearings and notification. They believe they can significantly change a long standing Colorado State Law without even going through the process required for a rule change, let alone the legislative process.
