These procedures became effective February 15, 2011 and were proposed by Erina Carey Cowan (Ethics/Grievances Chair) and Jackie Olsen (NTCB Executive Director). + Frequently Asked Questions

How Many CEUs are required for renewal?

1. All designations require 20 continuing education units (CEU) before your next certification renewal date:
 - A minimum of 10 CEU must be in the primary area of your designation (Biofeedback, Aromatherapy, Neurotherapy, Sound Therapy, etc.) Attending a yearly accredited organization Convention or Workshop may satisfy all 20 CEUs.
 - A maximum of 10 CEU may be earned in healthcare, alternative healthcare, or self-improvement courses, seminars or workshops intended to improve the clinical skills and business practices of the NTCB professional.
 - Instruction includes correspondence or Internet-based courses, audio or video tapes, telephone conferencing and face-to-face communications. There is no limit to the maximum number of

CEU that may be applied to re-certification. CEUs may be retained for a maximum of 3 years towards recertification.

- All CEU may apply to more than one NTCB certifications. Dual certification does not require double CEU for re-certification.
- Instructors are limited to a maximum of 10 CEU for being an instructor.

Health News

Last week, the Centers For Disease Control (CDC) released its 34th annual "Health, United States Report." The document is 550 pages of charts, tables and numbers about the state of healthiness across the nation. If you don't have time to read all this information.... Here's a brief summary:

1. Heart Disease is the leading cause of death; cancer is second.
2. Life Expectancy has increased to 77.9 years.
3. 20 percent of children are now considered obese between the ages of 6-11 years; 18 percent of those 12-19 years are also considered obese.
4. 34 percent of US adults are considered obese.
5. One-fifth of all adults work out at least 2 ½ hours per week.
6. Smoking remains unchanged – at least 20 percent of all adults smoke.
7. Death rate for adults age 25 to 44 decreased by 7 percent due to a reduction of cancer and HIV-related deaths.
8. The number of high school students having sex is up to 61 percent.
9. The overall percentage of adults 20 and older with high cholesterol -- defined as 240 mg/dL -- fell from 20 percent to 15 percent.
10. Between 2005 and 2008, 11 percent of all adults over the age of 20 had either diagnosed or undiagnosed diabetes. The number of adults with diabetes increased with age -- from 4 percent of all adults between 20 and 44 years old, to nearly 30 percent of all adults age 65 and older.
