#### **New Raindrop Designation**

NTCB and CARE have approved the Escent-Oil Balance Program to certify Raindrop Practitioners or Specialists in Animal Raindrop. All candidates for the CRP-A or BCRS-A designation must first complete the CARE Basic Training, another approved program of similar instruction, or credit for life experience, before beginning the Escent-Oil Balance Program which leads to certification as a CRP-A or BCRS-A. All candidates must also complete the Correspondence Courses, Basic Skills Workshop and Aromatherapy Intensive Paradigm.
