### **Attention Aromatherapy Professionals:**

1. NTCB is working with CARE and Dr. David Stewart (<http://raindropttraining.com>) and AromaSounds – under Dr. Christi Bonds-Garrett - to certify those members who are training in the use of tuning forks and aromatherapy. Complete Blueprints and applications will soon be posted on our website, but here’s some information to help you plan your studies:

**CARE:** Members who are currently certified as a CRTS or BCRS are eligible to be approved by CARE in Vibrational Raindrop Technique. Both of these certifications (CVRC – Certified Vibrational Raindrop Coach- and BCVRs – Board Certified Vibrational Raindrop Specialist) are awarded by the Natural Therapies Certification Board (NTCB). Members who are working with the vibrational technique are encouraged to attain the CVRC or BCVRs designation. You are not required to maintain the previous CRTS or BCRS designation when you do so, but should not use the CRTS or BCRS unless you are presently certified.

**AROMASOUNDS:** Those members taking advanced courses with AromaSounds who wish to be certified as Certified Raindrop Harmonics Specialist (CRHS) or Certified Raindrop Harmonics Coach (CRHC) - these are two different levels of certification and study - will first be approved by AromaSounds.

2. EOB (Escent-Oil Balance) – Candace Hoke – is also working on a program for Aromatherapy Coaches who come from a different oil technique background to become certified as Animal Raindrop Specialists.
