Body Balancer

Body Balancer: This is an adjunct to the LIFE System biofeedback device which has visual and auditory signals. It also is operated by itself and works well either with client in the office or remotely.

Visual: Offers **moving** imagery of fractals (pictures of organs, systems, chakras, etc.) and Sacred Geometry imagery.

Auditory: The sounds you may choose are various - including Solfeggio tones and Kings Chambers.

When combining the auditory and visuals with the Body Balancer, the body/field receives these energetic vibrations and uses them as needed.
