Changes to Harmonics Designation

Effective January 1, 2015, the requirements for Certification in Raindrop Harmonics have been changed. Two additional classes are required. The rationale is that a true Raindrop Harmonics Specialist should have a cursory understanding of the two other frequency systems of the Triad of microcosm (Sacred Solfeggio), mesocosm (Pythagorean), and macrocosm (Planetary).
